# NEED

- Dermatology trial conducted in US, Belize and India with over 25 sites and 800 subjects.
- Jubilant Clinsys was contracted to perform database design and validation, full data management, eCTD compliant CSR submission, US and Belize clinical and medical monitoring activities for the client.
- Clinical and medical monitoring activities for India were conducted by a different CRO.
- Extremely aggressive timelines were implemented since the client wanted to submit the FDA application before end of the year.
- Subject completion windows were spread out widely as site activation occurred at different time points in the study across the three participating countries.

### **APPROACH**



- Jubilant Clinsys operational teams worked closely with their counterparts at the other CRO ensuring smooth progress at all stages of the study.
- Wide array of real time study reports within TrialStat were identified.
- Projection of study completion dates enabled the Jubilant Clinsys teams to model a staggered database lock scenario across the three countries.
- Protocol deviations and granting of protocol deviations needed to be standardized across the three countries.
- Coding of Medical Histories, Adverse Events and Concomitant Medications had to be consistent globally.
